Summary of Unit 1 Operation

Unit 1 remained in Mode 1 (Power Operation) during October 1998. On October 27, 1998, power was reduced to approximately 70 percent in order to perform maintenance on a level control valve for the Heater Number 2 Drain Tank. On October 28, 1998, Unit 1 returned to approximately 100 percent power.

Summary of Unit 2 Operation

Unit 2 remained in Mode 1 during October 1998. There were no significant operational activities.

Actuations of Steam Generator Safety or Pressurizer Power Operated Relief Valves

There were no challenges to the steam generator safety valves or pressurizer power operated relief valves.
