

STATISTICAL ANALYSIS FOR REPORTING PERIOD JANUARY THROUGH JUNE 1999

Analysis of the data indicates that 25.7 percent of the average eligible population was randomly tested from January through June 1999.

The random positive rate for all workers at DCCP from January through June 1999 was 0.74 percent. The licensee employee random positive test rate was 0.79 percent. Contractor employee random positive rate was 0.64 percent.

The overall positive test rate was <u>1.61</u> percent. Preaccess tests for short term contractor personnel accounted for 83.3 percent of all positive tests. The large number of positive tests recorded for short term contractor personnel in the preaccess testing category is attributable to the 1R9 refueling outage.

PG&E submitted blind performance specimens in accordance with 10CFR26, Appendix A, Section 2.8.(e)(2), requirements. There were no reportable events.
