This refers to the routine inspection conducted by M. Miller, M. Tschiltz, D. Corporandy, F. Huey and D. Kirsch during the period from September 29 through November 3, 1993. This inspection examined your activities as authorized by NRC License Nos. DPR-80 and DPR-82. At the conclusion of the inspection, the inspectors discussed their findings with members of the PG&E staff.

Areas examined during this inspection are described in the enclosed inspection report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspectors.

Based on the results of this inspection, it appears that certain of your activities were not conducted in accordance with NRC requirements, as discussed in Paragraph 4 of the enclosed inspection report. Because various procedures were not properly followed, your staff was not in full compliance with NRC requirements. In view of the corrective actions your staff has taken and has planned for future implementation, and because the criteria of the NRC Enforcement Policy were satisfied, this violation was not cited.

In accordance with 10 CFR 2.790(a), a copy of this letter, the enclosures, and your response will be placed in the NRC Public Document Room.

Should you have any questions concerning this inspection, we will be pleased to discuss them with you.
