On October 23 and 24, 1986, a workshop was held to review and discuss the technical progress and interim results of Phase III of the Diablo Canyon Long Term Seismic Program (LTSP) in the area of ground motions. The workshop, which was conducted under the joint auspices of the Nuclear Regulatory Commission and Pacific Gas and Electric Company, was one of a series of publicly announced meetings to inform the NRC Staff of work performed toward satisfaction of the terms of Diablo Canyon Unit 1 license condition 2.C.(7) which establishes the requirement for a long-term seismic program.

The enclosed report summarizes the results of the program studies as of early October 1986. It should be clearly recognized that the results presented in this report are interim, not final. They represent the status of the program after the initial task work had been completed.

A separate workshop was conducted on October 21 and 22, 1986, regarding the topic of geology, seismology, and geophysics. This workshop was summarized in a separate report transmitted March 11, 1987.
