

The generic letter requires that licensees implement formalized procedures or administrative controls to assure long-term implementation of its erosion/corrosion monitoring program and that these procedural controls consist of systematic measures to ensure that erosion/corrosion does not lead to degradation of single-phase and two-phase high-energy systems using carbon steel piping and components.

As described in PG&E letter DCL-87-217, dated September 8, 1987, the Diablo Canyon erosion/corrosion monitoring program was initially implemented in late 1986. The inspection program is based on NUMARC and EPRI guidelines as endorsed by the NRC. The program is implemented each refueling outage in accordance with Project Instructions I-66, "Pipe Wall Thickness Measurements for the Erosion/Corrosion Monitoring Program," and I-67, "Acceptance Criteria for Piping Erosion/Corrosion."




