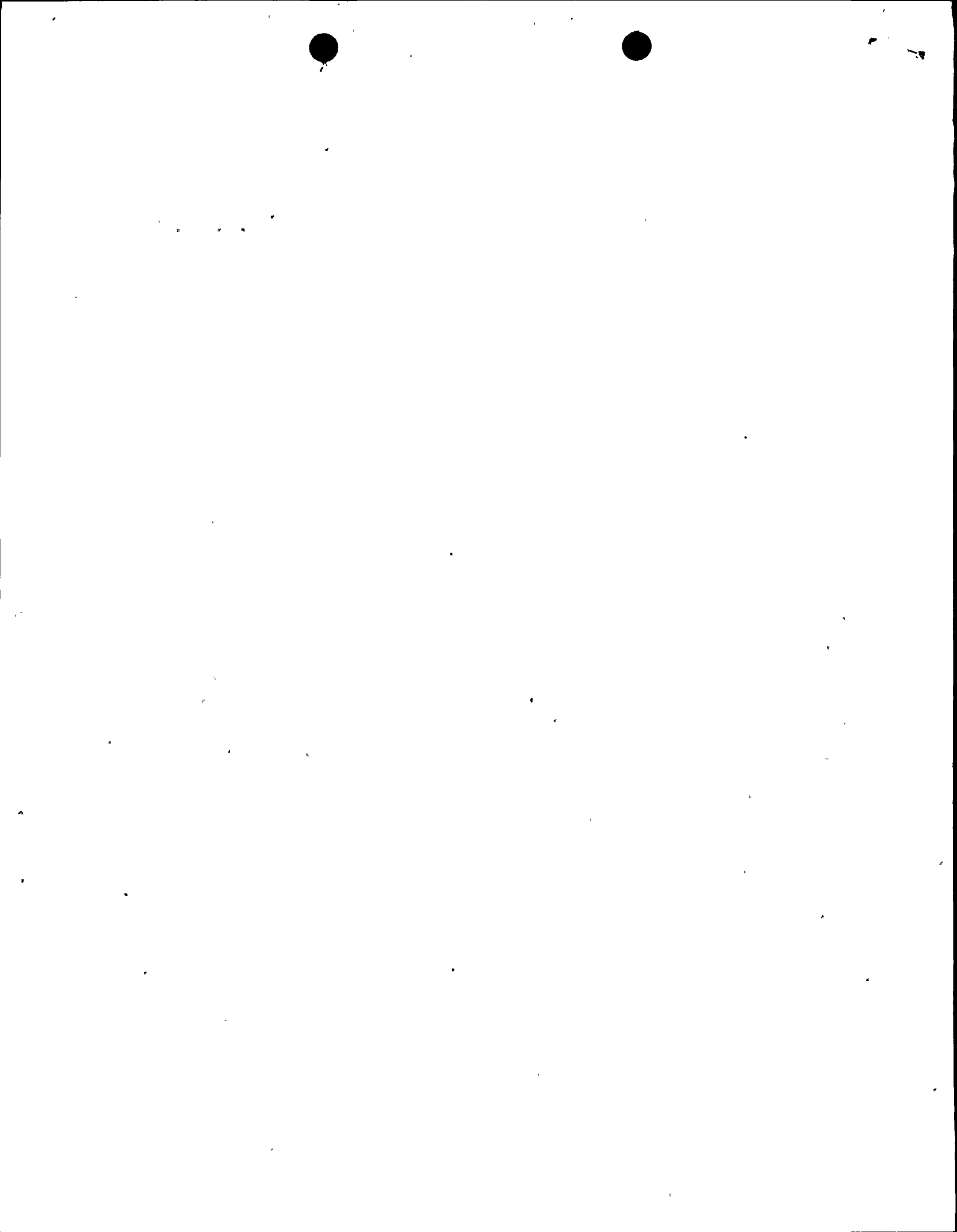

NRC Final Policy Statement and NUREG-1431, Rev. 1

Gentlemen:

Enclosed is an application for amendment to Facility Operating License Nos. DPR-80 and DPR-82 for Diablo Canyon Power Plant Units 1 and 2, respectively. The license amendment request (LAR) proposes to relocate selected Technical Specifications (TS) in accordance with the Commission's Final Policy Statement for relocation of current TS that do not meet any of the screening criteria for retention.

The selected TS contained in this LAR for relocation, will eliminate or minimize interaction with PG&E's current work on the 24 month fuel cycle LARs, the first of which is expected to be submitted in December 1995. This will result in reducing the NRC review resources for the 24 month fuel cycle program. Other TS relocation submittals will be made to the NRC when appropriate.

PG&E believes this request should be considered a cost beneficial licensing action in accordance with NRC Administrative Letter 95-02.

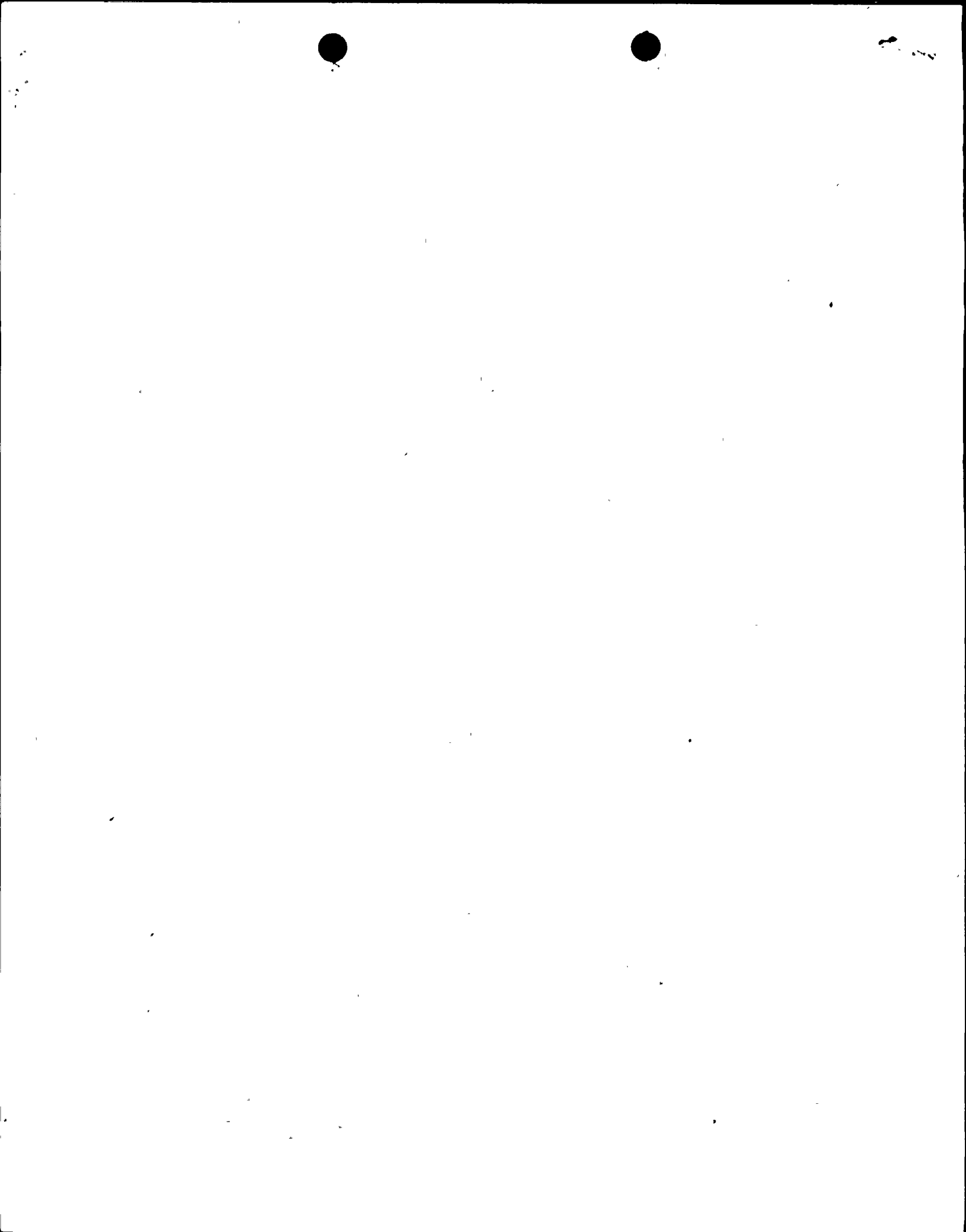
PG&E requests that the NRC assign a medium priority for review of this LAR. Due to the number of plant procedures affected by this change, PG&E requests
