

Dear Commissioners and Staff:

PG&E submitted License Amendment Request (LAR) 97-04, "Steam Generator Tube Alternate Repair Criteria for Indications in the Westinghouse Explosive Tube Expansion (WEXTEX) Region," to the NRC on March 10, 1997. The LAR requested NRC review and approval of implementation of steam generator tube alternate plugging criteria for axial indications in the Westinghouse explosive tube expansion region that exceed the current Technical Specification depth-based plugging limit.


On March 13, 1998, PG&E responded to a January 6, 1998, NRC request for additional information (RAI) in PG&E Letter DCL-98-039, "Response to Request for Additional Information License Amendment Request 97-04."

In a letter to PG&E dated June 23, 1998, the NRC staff requested additional information based on their review of the information provided in PG&E Letter DCL-98-039. PG&E's response to this RAI is provided in Attachment A. It contains Table 1-1, "Additional Loss Coefficient Data For Table 6.2-3 of WCAP-14797 (Proprietary)," and Table 1-2, "Additional Loss Coefficient Data For Table 6.2-3 of WCAP-14797 (Nonproprietary)," which is the nonproprietary version of Table 1-1.

Since Attachment A contains information proprietary to Westinghouse Electric Corporation, Attachment B contains a Westinghouse Application for Withholding Proprietary Information from Public Disclosure, a Proprietary Information Notice, and accompanying Affidavit CAW-98-1283 signed by Westinghouse, the owner of the information. The affidavit sets forth the basis on which the information may be withheld from the public disclosure by the Commission, and it addresses with specificity the considerations listed in paragraph (b)(4) of 10 CFR 2.790 of the Commission's regulations.
