INSTRUCTIONS TO STUDENTS

ACCEPTANCE: This is to advise you that those individuals listed on Enclosure (1) have been accepted for participation in the fiscal year 2017 Integrated Materials Performance Evaluation Program (IMPEP) Team Member training. This course is scheduled to be presented February 13-15, 2017, at the U.S. Nuclear Regulatory Commission's (NRC) Professional Development Center (PDC). The PDC is located at the Three White Flint North building which is situated across Marinelli Road from One White Flint North between the White Flint Metro station entrance and the Metro parking garage. The address for the building is 11601 Landsdown Street, North Bethesda, MD 20852. Please allow sufficient time to process through security upon arrival. You will be required to show proof of identification when you arrive. After you have processed through security, you will be escorted by an NRC employee to the 2nd floor where the training will be held.
