
14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purpose of this modification is to provide incremental funding in the amount of \$100,000.00, thereby increasing the total obligation from \$600,200.00 to \$700,200.00. Therefore Section B.2 NRCB070 CONSIDERATION AND OBLIGATION-COST-PLUS-AWARD-FEE, paragraph (g) is revised as follows:

The amount currently obligated by the Government with respect to this contract is \$700,200.00 of which \$606,968.00 is cost and of which \$67,932.00 is award fee, of which \$25,300.00 is base fee.
