

General NRC Comments on NEI's Binning of NRC Comment on Appendix D Screening and Definitions

By letter dated April 4, 2016 (ADAMS Accession No. ML16126A197) NEI docketed NEI 96-07 Appendix D for NRC Review. Subsequently, in support of public meetings on June 15, 2016 and September 21, 2016, the NRC provided DRAFT comments on Appendix D "Definitions" and "Screening" sections (ADAMS Accession Nos. ML16166A339 & ML16260A019 respectively). Note: NRC comments are sequentially numbered, and not all comments were provided to NEI.

Subsequently, by emails dated November 8, 2016, and November 10, 2016 (ADAMS Accession Nos. ML16334A002 & ML16334A000), NEI commented by binning the comments as described below:
