This refers to your license amendment request dated September 2, 2016. Please find enclosed Amendment No. 61 authorizing Kevin G. Kett, M.D. as an Authorized User and removing Drs. Matthew Bushey and Peter Chia-Gee Chien as Authorized Users. In addition we have added the modified dressing room described in your letter to the areas of use of licensed materials under your NRC license.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
