Dear Congressman Kilmer:

On behalf of the U.S. Nuclear Regulatory Commission (NRC), I am responding to the December 12, 2016, letter from you and your colleagues regarding NRC regulation and oversight of naval vessel decommissioning and related activities. Responses to your specific questions are enclosed with this letter.

At the outset, it is important to clarify that under section 91.a(3) of the Atomic Energy Act the oversight of Naval Reactors' (or its contractor's) work related to decommissioning of naval vessels is the responsibility of the Department of Energy (DOE). When the NRC was created by the Energy Reorganization Act, this responsibility was assigned exclusively to the Energy Research and Development Administration, which was later folded into DOE. The NRC has consistently maintained that the NRC does not have jurisdiction over DOE activities that have been exclusively reserved to DOE. We recognize that DOE holds a different view, and that both agencies have respectfully asserted these different views since at least 1998. The NRC staff and Naval Reactors have had several recent discussions regarding agency perspectives on the jurisdictional issues. The NRC remains open to further discussion on these issues with Naval Reactors and other stakeholders.

Although the NRC does not have authority over these activities, in the past, the NRC has effectively provided Naval Reactors with technical assistance through reimbursable agreements on matters for which the NRC has technical expertise but does not have jurisdiction. Naval Reactors funded these activities. Likewise, here, Naval Reactors could decide to seek technical assistance from the NRC for specific projects concerning the decommissioning of naval vessels. The NRC staff is currently discussing the technical parameters of a potential reimbursable agreement with Naval Reactors. The NRC's resources associated with such work would depend on its specific scope.
