SIA Solutions LLC (SIA) provided radiological brokerage services to the Holbrook Defense Logistics Agency (DLA), Holbrook, New York for the packaging, manifesting, shipping, and disposal of scrap metal and debris intermixed with low-level radioactive materials. The scrap and debris were disposed of at U.S. Army Joint Munitions Command (JMC) approved facility.

This information is being transmitted to you as required by condition 17 of the SIA Materials License.

The following work evolutions associated with this job site occurred:

- (1) SIA provided radiological broker services to the Holbrook DLA to prepare and package for transport, unwanted metal scrap and debris containing low-level radioactive materials that were stored at the Crestwood Metals Yard facility servicing the DLA (Site). The contaminated scrap and debris were removed and sent to U.S. Ecology, Grand View, Idaho for disposal.
- (2) The subject materials were consigned to and transported to the JMC approved disposal facility. SIA did not take possession of any radioactive materials derived from the site.
- (3) Radiological surveys were conducted by SIA after completion of work activities at the Holbrook, New York DLA to ensure the absence of contamination on work areas affected during work evolutions and to ensure DOT transportation compliance.
- (4) No SIA related radioactive sources remain on the Site. All radioactive materials associated with this work evolution were removed from the Site for transportation and disposal; SIA personnel left the Site on December 8, 2016.
