Please find enclosed Amendment No. 22 authorizing the removal of your facility located at La Fuente Town Center, Suite 11104, 706 Marginal, Guayama, Puerto Rico from your NRC license. This facility may be released for unrestricted use.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
