SUBJECT: REQUEST FOR AMENDMENT TO LICENSE SNM-2016 TO ADD A TEMPORARY WORKSITE (COST ACTIVITY CODE L33417)

Dear Mr. Johnson:

On May 26, 2016, you submitted a License Amendment Request to add a temporary worksite for the purpose of characterizing a non-intrusive cargo inspection system at an additional location apart from the approved facility in Billerica, MA. The additional cargo screening facility will be located at the Port of Boston, 940 East 1st St. Boston, MA 02127.

The amendment included details regarding storage, security, and handling. On August 18, 2016, you responded (Agencywide Documents Access and Management System (ADAMS) Accession Number ML16237A294) to our Request for Additional Information (RAI) sent to you on July 19, 2016 (ADAMS Accession Number ML16200A196). This was supplemented by revised applications dated November 15, 2016 (ADAMS Accession Number: ML16323A320) and December 8, 2016 (ADAMS Accession Number ML16347A113).

We have reviewed the submittals and are enclosing the Safety Evaluation Report of our review. Based on the review and the commitments made in the amendment request we find the proposed changes acceptable. The amendment is approved and public and non-public versions of the amended license SNM-2017 are enclosed. License Condition 9 is modified to specify that authorized use is in accordance with the terms of your application. License Condition 10 has been modified to add the temporary location as an authorized place of use. Be advised that this location is authorized for the duration of this testing cycle and with the specified material only. Any future testing at this location or any other would require a separate amendment to provide detail on circumstances and conditions. Cost Activity Code L33417 is considered closed.
