SUBJECT: REQUEST FOR WITHHOLDING INFORMATION FROM PUBLIC DISCLOSURE
FOR LIMERICK GENERATING STATION, UNIT 2 (CAC NO. MF8943)

Dear Mr. Hanson:

By letter dated December 16, 2016 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML16351A078), Exelon Generation Company, LLC (Exelon) submitted an affidavit dated November 17, 2016, executed by Mr. Brian R. Moore of Global Nuclear Fuel - Americas, LLC (GNF-A). Exelon requested that the information contained in Attachment 3 to its letter be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Section 2.390. Specifically, Exelon requested that the following document be withheld:

GNF Additional Information Regarding the Requested Changes to the Technical Specification SLMCPR [Safety Limit Minimum Critical Power Ratio], Limerick Unit 2, Cycle 15.

A non-proprietary copy of the document has been placed in the U.S. Nuclear Regulatory Commission's (NRC's) Public Document Room and added to the ADAMS Public Electronic Reading Room.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- (4)a. Information that discloses a process, method, or apparatus, including supporting data and analyses, where prevention of its use by GNF-A's competitors without license from GNF-A constitutes a competitive economic advantage over other companies.
- (4)b. Information which, if used by a competitor, would reduce his expenditure of resources or improve his competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing of a similar product.


