Dear Dr. Jursinic:

Enclosed is Amendment No. 105 to your NRC Material License No. 21-12275-02 in accordance with your request.

Please note that we were unable to approve your request for the use of yttrium-90 TheraSperes, as permitted by 10 CFR 35.1000, at this time. If you wish to pursue this request, please submit a written, currently dated, and signed response, including the additional information discussed below.

Please include documentation that the RSO has obtained the requisite training in the radiation safety, regulatory issues, and emergency procedures for the new use for which you are seeking approval. Please also include a new delegation of authority, signed by both the RSO and licensee management, which includes the use of yttrium-90 TheraSperes, as permitted by 10 CFR 35.1000.

In addition, please include the documentation of training and experience for the proposed authorized user. This training and experience should include the topics discussed in the licensing guidance, "Yttrium-90 Microsphere Brachytherapy Sources and Devices, TheraSphere and SIR-Spheres Licensing Guidance," dated February 12, 2016. Please also include in the documentation the clinical use experience provided to the proposed authorized user.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.


