Enclosed is Amendment No. 88 to your NRC Material License No. 13-06009-01 in accordance with your request.

**Please note that we have reformatted your license in our new Web Based Licensing (WBL) system. As a result, changes to your license have been made so please review the enclosed document carefully and be sure that you understand all conditions.**

**If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.**

**We deleted Condition No. 14 from your license, as it appeared on Amendment No. 87, in favor or referencing 10 CFR Part 71 in the Preamble at the top of page one of your license.**

**Please note that we updated the authorization for Shih Jack Wei, M.D. to more correctly reflect the limitation for his authorization for materials in 10 CFR 35.300.**

**Please note that we also deleted authorization for strontium-90 in 10 CFR 35.400 and Proxima's GliaSite RTS from Authorized Medical Physicists (AMP) Andrea D. Browne, Ph.D., A. Carl Warner, M.S. and Paul Mason, M.S. This is because your license no longer authorizes strontium-90 in 10 CFR 35.400 and Proxima's GliaSite RTS, licensed under 10 CFR 35.1000, does not require an AMP.**

**As stated in NUREG 1556, Vol. 9, Rev. 2, Section 9 on page 9-1, "Licensees are responsible for applying for amendment to licenses and for keeping them up-to-date."**

**It appears that your license authorizes two HDR devices, although only one is actually in use. If the old HDR device and sources have been permanently disposed of from this license, it is incumbent upon you to update the license accordingly.**

**In reviewing some of your license's history, it appeared that the old HDR device and sources may have been permanently disposed of in 2015, more than one year ago. If this is not the case, please contact me.**

The enclosed document contains sensitive security-related information.  
When separated from this cover letter this letter is uncontrolled.

**If this is, in fact, the case, please submit an appropriate amendment request within 30 days of the date of this letter requesting the permanent removal of your old HDR device and sources.**

**If you are unsure of the information needed to effect this removal, please contact me to discuss this. If an alternative timeframe is needed for response, please contact me to discuss that also.**

**I also noted that your letter dated August 25, 2015, in item 5, refers to a statement made in your application dated December 23, 2013, concerning commitments made in Amendment No. 81 dated "July 12, 2012."**

**Amendment No. 81 to your license was dated July 16, 2012. Please correct this in your response also when submitting the information to remove the old HDR device and sources from your license.**

**Please address your responses to my attention as "additional information to control number 592087."**

**In addition, if there are any other authorizations on your license that are no longer in practice, please contact me and request amendment to your license to remove them also. For example, it is not clear whether the Proxima GliaSite RTS is still being manufactured and used.**

**Please ensure that a senior management official signs this amendment request, in accordance with 10 CFR 35.12(a).**
