Please complete the Travel Application Form which will be provided to you and submit to Marcia Casby, [ASTrainingandtravel.Resource@nrc.gov](mailto:ASTrainingandtravel.Resource@nrc.gov), no later than Friday, January 20. Individuals should request the Federal government rate at the hotels. The per diem for Houston, Texas is \$135 hotel and \$59 meals and incidentals. Rental cars are not reimbursable.
