Block 10 – Remove reference to Waste Classification as defined in CFR 61.55 and reference to Table A2 values of 49 CFR 173.435 from the waste description.

Radioactive waste consisting of up to 5,500 tons of material contaminated with various radionuclides in varying combinations imported from Canada under NRC Import License IW022 and subsequent amendments. This includes waste which may need to be returned to the Canadian generators (designated ultimate consignees) for disposition. Such waste could include material that could not be recycled for beneficial reuse, or does not conform to the specification, and/or has been processed for volume reduction and is directly attributable to processing the material imported under IW022 and subsequent amendments. Given there will be numerous shipments from the Canadian Points of origin specified, the total combined activity levels for all of the radioactive contaminants for the materials export under this license will not at any time exceed the license's domestic possession limits. Likewise, no one shipment will exceed 10 CFR Part 110, Appendix P, Table 1 Category 2 thresholds. Waste classification as defined in CFR 61.55 is not applicable to this exported license since all treated and processed waste are returned to the ultimate consignee in Canada. Waste returned to Canada under this export license can exceed Table A2 values of 49 CFR 173.435 if the radioactivity is within the State of Washington issued Radioactive Materials License and meets all Department of Transportation requirements for transporting the waste.

With the removal of the reference to waste classification, Perma-Fix may receive Class A, B, or C wastes.

**Application for License Amendment/Renewal: 1) License to Import Radioactive Material  
2) License to Export Radioactive Material**

Dear Mr. Skeen:

Perma-Fix Environmental Services, Inc. requests issuance of a license amendment/renewal to the Perma-Fix Northwest, Inc. (PFNW) License to Import Radioactive Material IW022/04 and License to Export Radioactive Material XW012/04.

This amendment/renewal application requests:

1. Changes to contact information.
2. Extends import/export license for an additional five years.
3. Change the name of one Point of Origin entity (multiple locations).
4. Remove reference to waste classification to allow for receipt of Class A, B or C waste streams. Waste classification is only applicable to waste being disposed of in the US. Removal of this reference will allow for receipt of waste streams at our PFNW facility regardless of waste classification. All receipts will meet DOT packaging, labeling, manifesting and shipping requirements.
5. Remove reference to "waste cannot exceed Table A2 values of 49 CFR 173.435". Removal of this reference does not remove any DOT requirements. All shipments will be packaged, labeled, manifested and shipped per applicable DOT requirements.

The appropriate applications are attached. A payment of \$18,800 was previously submitted to the NRC therefore is not included as part of this submittal.
