SUBJECT: SUMMARY OF A PUBLIC MEETING WITH SOUTHERN NUCLEAR
OPERATING COMPANY AND SOUTH CAROLINA ELECTRIC & GAS
ON OCTOBER 27, 2016

The U.S. Nuclear Regulatory Commission (NRC) staff held a Category 2 public meeting with Southern Nuclear Operating Company (SNC) and South Carolina Electric & Gas (SCE&G) on October 27, 2016. The purpose of the meeting was to discuss issues associated with the safety review of licensing actions for SNC's Vogtle Electric Generating Plant (VEGP) Units 3 and 4, and SCE&G's Virgil C. Summer Nuclear Station (VCSNS) Units 2 and 3.

Summary of Meeting:

On October 27, 2016, staff from the NRC conducted a public meeting with representatives from SNC and SCE&G to discuss issues associated with the safety review of licensing actions for SNC's VEGP Units 3 and 4, and SCE&G's VCSNS Units 2 and 3. Specifically, the meeting discussed (1) digital I&C ITAAC completion for VEGP Units 3 and 4 and VCSNS Units 2 and 3 and (2) two UINs for VEGP Unit 3.

In the open portion of the meeting, the first topic discussed was digital I&C ITAAC completion. The staff walked through the talking points associated with this topic, discussing the four ITAAC that require development, using rigorous design processes, of the AP1000 Protection and Safety Monitoring System (PMS), the PMS Component Interface Module (CIM), and the Diverse Actuation System (DAS). The staff described their position and expectation for the completion of these ITAAC, noting that the ITAAC require that an inspection be performed to support the implementation of the digital I&C components and validate that the process has the necessary rigor and robustness to yield appropriate design outputs and address the complexities of digital I&C design and development. The licensees asked clarification questions to ensure a common understanding of their approach for the PMS, PMS-CIM, and DAS digital I&C ITAAC, including expectations for PMS software maintenance during the Initial Test Program. The staff noted that they will respond to SNC's letter ND-16-0753 (ADAMS Accession No. ML16138A305) in the future to formally document their position regarding digital I&C ITAAC completion.

The second topic discussed was two UINs for VEGP Unit 3. Regarding the UIN for ITAAC 2.3.02.14, the staff noted that they realized that combined license Appendix C Table 2.3.2-2 had been revised in an approved license amendment request, and therefore, their concern was no longer applicable. As submitted, the UIN correctly lists the Line Numbers. Regarding the UIN for ITAAC 2.5.05.03b, the staff noted that the ITAAC Completion Description does not provide sufficient information with respect to installation of the sheathing on the thermocouple wires and that the inspection should not only verify that it is present, but should also verify that it is installed in a manner to be capable of performing its function. SNC noted that the inspection is performed in accordance with the listed references, which would verify that the sheathing on the Thermocouple wires are installed in a manner to be capable of performing its function. The staff noted that the ITAAC Completion Description should specify that as well. SNC stated that they would consider revising the UIN to specify that the inspection confirms that the sheathing is installed in a manner to be capable of performing its function.

At the end of each topic, there was an opportunity for the public to provide comments and ask questions. All comments and questions were addressed before moving to the next topic or to the closed portion of the meeting.

At the conclusion of the open portion of the meeting, a closed meeting was held with the licensees (SNC and SCE&G) to discuss their security plan related to special nuclear material. All information related to this topic is withheld from public disclosure as Security-Related Information.
