



Summary of Meeting:

On November 10, 2016, staff from the NRC conducted a public meeting with representatives from SNC and SCE&G to discuss issues associated with the safety review of licensing actions for SNC's VEGP Units 3 and 4, and SCE&G's VCSNS Units 2 and 3. Specifically, the meeting discussed staff comments on VEGP Units 3 and 4 ICNs and VEGP Unit 3 UINs.

The meeting discussed the VEGP ICNs and UINs listed in the referenced document. The staff provided a general comment that applies to many of the ICNs and UINs discussed, stating that it is the staff's expectation that the notifications reference the applicable American Society of Mechanical Engineers (ASME) code year and addenda, as well as the applicable section and articles used. The staff noted that this expectation applies not only to ASME but to any code or standard referenced. Regarding the ICN for ITAAC 435, SNC noted that there is another ITAAC requiring ASME hydrostatic testing for the piping system that would require the N-5 data report to be compiled before the ITAAC can be completed. The staff noted that that information should be explicitly called out in the ICN for ITAAC 435 and that the ICN should also state that the component test was not performed in the as-built condition. The staff discussed the remaining comments in the "Issue" column of the referenced document. SNC stated that they would consider revising the ICNs and UINs to incorporate the staff's comments.

At the end of the meeting, there was an opportunity for the public to provide comments and ask questions. All comments and questions were addressed before ending the meeting.
