THE VIRGIL C. SUMMER NUCLEAR STATION UNITS 2 AND 3: IRWST
VOLUME CHANGES (CAC NO. RG3031) (LAR 16-20)

Dear Mr. Jones:

By letter dated December 6, 2016, (Agencywide Documents Access and Management System Accession No. ML16342B712), South Carolina Electric & Gas Company (SCE&G) on behalf of itself and the South Carolina Public Service Authority, submitted a request for a license amendment and exemption for the Virgil C. Summer Nuclear Station (VCSNS), Units 2 and 3 (Combined License (COL) Nos. NPF-93 and NPF-94). In that letter, SCE&G proposes changes to the Updated Final Safety Analysis Report (UFSAR) in the form of departures from a plant-specific Design Control Document (PS-DCD) Tier 2 table, COL Appendix A Technical Specifications, and a COL Appendix C table. The proposed departures consist of in-containment refueling water storage tank (IRWST) minimum volume changes in plant-specific UFSAR Table 14.3-2, COL Appendix A Technical Specifications 3.5.6, 3.5.7 and 3.5.8 and Surveillance Requirements 3.5.6.2 and 3.5.8.2, COL Appendix C Table 2.2.3-4, and Tier 1 Table 2.2.3-4. The proposed changes restore consistency of these sections with the UFSAR IRWST minimum volume value in other locations. Because this proposed change requires a departure from Tier 1 information in the Westinghouse AP1000 DCD, the licensee also requested an exemption from the requirements of the Generic DCD Tier 1 in accordance with 10 CFR 52.63(b)(1).

The purpose of this letter is to provide the results of the U.S. Nuclear Regulatory Commission (NRC) staff's acceptance review of these requests. The acceptance review was to determine if there was sufficient technical information in scope and depth to allow the NRC staff to complete its detailed technical reviews. The acceptance review was also intended to identify whether the application has any readily apparent information insufficiencies in its characterization of the regulatory requirements or the licensing basis of the plant.

Consistent with Title 10 of the *Code of Federal Regulations* (10 CFR) Section 50.90, an application for an amendment to the license must fully describe the changes requested, and follow as far as applicable, the form prescribed for original applications. 10 CFR Section 52.79 addresses content of technical information that is required for COL application Final Safety Analysis Reports. This section stipulates that the submittal address the design and operating characteristics, unusual or novel design features, and principal safety considerations.

The NRC staff has reviewed your application against the regulatory requirements and has concluded that it provides sufficient technical detail to enable the NRC staff to complete its detailed review and make an independent assessment regarding the acceptability of the proposed changes in terms of regulatory requirements and the protection of public health and

safety and the environment. Given the lesser scope and depth of the acceptance review as compared to the detailed technical review, there may arise issues that impact the NRC staff's ability to complete the detailed technical review despite an adequate acceptance review. You will be advised of any further information needed to support the NRC staff's detailed technical review by separate correspondence.
