SUBJECT: SUMMARY OF A PUBLIC MEETING WITH SOUTHERN NUCLEAR
OPERATING COMPANY AND SOUTH CAROLINA ELECTRIC & GAS
ON DECEMBER 15, 2016

The U.S. Nuclear Regulatory Commission (NRC) staff held a Category 2 public meeting with Southern Nuclear Operating Company (SNC) and South Carolina Electric & Gas (SCE&G) on December 15, 2016. The purpose of the meeting was to discuss issues associated with the safety review of licensing actions for SNC's Vogtle Electric Generating Plant (VEGP) Units 3 and 4, and SCE&G's Virgil C. Summer Nuclear Station (VCSNS) Units 2 and 3.

Summary of Meeting:

On December 15, 2016, staff from the NRC conducted a public meeting with representatives from SNC and SCE&G to discuss issues associated with the safety review of licensing actions for SNC's VEGP Units 3 and 4, and SCE&G's VCSNS Units 2 and 3. Specifically, the meeting discussed staff comments on (1) VEGP Unit 3 UINs regarding leak before break ITAAC and (2) VCSNS Units 2 and 3 ICN supplements for ITAAC 2.6.01.02.ii.

The first topic discussed was three UINs for VEGP Unit 3 (ITAAC 2.1.02.06, 2.2.04.06, and 2.3.06.06) regarding leak before break. The staff provided comments, stating that these UINs should include a statement that says the as-built leak before break evaluation reports conclude that the as-built piping is bounded by the curves in the AP1000 Design Control Document. SNC noted that they understood the staff's comment and would incorporate that language into the UINs and resubmit them for staff review.

The second topic discussed was VCSNS Units 2 and 3 ICN supplements for ITAAC 2.6.01.02.ii. The staff stated that these should be submitted as ITAAC Post-Closure Notifications in accordance with Title 10 of the *Code of Federal Regulations* (10 CFR) 52.99(c)(2). SCE&G stated that they understood the staff's comment and would resubmit the documents as ITAAC Post-Closure Notifications.

The NRC staff additionally provided preliminary comments regarding UINs for electrical system ITAAC and ICNs and UINs for human factors engineering ITAAC. The staff noted that these preliminary comments would be vetted through management and discussed in a future public meeting, if necessary.

At the end of each topic, there was an opportunity for the public to provide comments and ask questions. All comments and questions were addressed before moving to the next topic or ending the meeting.
