Dear Dr. Hill:

I would like to nominate several NRC staff to be the authorized NRC representatives or alternates on various committees of the Joint Committee on Nuclear Risk Management (JCNRM). These individuals, listed in Enclosure 1, are nominated because they bring the necessary expertise and education to support development and maintenance of PRA standards for their proposed area. In addition, several NRC staff that are currently serving on JCNRM committees are no longer able to participate. I request that you remove them as representing the NRC from the indicated JCNRM committees.

This nominating letter supersedes a nomination letter I sent you on November 2, 2016, nominating Christopher Fong (ADAMS Accession No: ML16302A107) to various JCNRM committees. That letter was not clear regarding the nomination and therefore, is superseded by this letter.

In accordance with the Office of Management and Budget Circular No. A-119, "Federal Participation in the Development and Use of Voluntary Consensus Standards and in Conformity Assessment Activities," January 27, 2016, the participation on a committee of an NRC-authorized representative does not connote agency agreement with, or endorsement of, decisions reached by the committee, or of standards approved and published as a result of the committee's efforts. Agency representatives participating on consensus standards developing groups will, to the extent possible, ascertain the views of the agency on matters of interest and will express views that are consistent with established agency views. However, the NRC's endorsement of these standards, if desired by the NRC, would be part of a separate activity, such as incorporation by reference into rulemaking or endorsement in an NRC regulatory guide.
