This refers to your license amendment request letter dated November 7, 2016. Please find enclosed Amendment No. 49 authorizing Ritchie D. Buschow as the Radiation Safety Officer. The license format is revised based on the NRC's current policy, most notably the page orientation is in the landscape mode and the authorized use section is now listed adjacent each material authorized.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
