Dear Dr. Kayser:

On September 12-16, 2016, Betsy Ullrich, James Cassata and Leo Wardrobe of this office conducted a security inspection at your facility, with continued in-office review through December 20, 2016. The inspection was an examination of your licensed activities as they relate to security of radioactive materials and to compliance with the Commission's regulations and the license conditions. The inspection consisted of observations by the inspectors, interviews with personnel, and a selective examination of representative records. The findings of the inspection were discussed with you and others of your organization at the conclusion of the inspection.

Two licensee-identified violations were reported to the inspectors during the inspection. The NRC determined that they were Severity Level IV violations. Because of the security-related nature of the violations, the characterization will not be provided in this letter, but instead is provided in a non-public enclosure. The violations were evaluated in accordance with the NRC Enforcement Policy. The current Enforcement Policy is included on the NRC's Web site at <a href="http://www.nrc.gov/about-nrc/regulatory/enforcement/enforce-pol.html">http://www.nrc.gov/about-nrc/regulatory/enforcement/enforce-pol.html</a>.

The violations are being treated as Non-Cited Violations, consistent with Section 2.3.2 of the Enforcement Policy, because: 1) NIST identified the violations and corrected them within a reasonable period of time; 2) the violations were not repetitive as a result of inadequate corrective action; and 3) they were not willful.

The NRC has concluded that information regarding the reason for the violations, the corrective actions taken and planned to correct the violations and prevent recurrence, are already adequately addressed in our records. Therefore, you are not required to respond to this letter unless the description of your corrective actions in the enclosure does not accurately reflect your actions or your position.
