

The purpose of this modification is to incorporate additional contract line items (CLINs) for new voicemail system installation services and audit support services for authority to operate (ATO) the PBX and voicemail systems. This modification also incorporates an additional CLIN for emergency equipment and supplies for the PBX, voicemail system and associated components. Therefore the table is revised to add CLINs 3013, 3014 and 3015. This modification also increases the level of effort for Project Supplemental Support - CLINs 3002 and 4002, and Power outage support – CLINs 3011, 3012, 4011, and 4012 for the PBX, voicemail system, and associated components. As a result of the new system install, CLINS 3004,3008, and 3009 were slightly reduced in price. In addition the Optional Tasks CLINs 0007 was not exercised and is deleted.

As a result of this modification and previous errors in other modifications, Section B.1 and B.2 are revised in their entirety to show the correct values and ensure the accounting information is correctly captured.

### B.1 CONSIDERATION AND OBLIGATION—TIME AND MATERIALS CONTRACT (AUG 2011)

(a) The total ceiling of this contract including options is \$575,777.74. The total estimated amount of this contract (ceiling) for the services ordered, delivered, and accepted under this contract is \$457,750.11. The unexercised ceiling remaining is \$118,027.63 for Option Year 2.

(b) The contract includes: (direct labor hours at specified fixed hourly rates, inclusive of wages, fringe, overhead, general and administrative expenses, and profit.

(c) The amount presently obligated by the Government with respect to this contract is \$346,031.73

(d) This is an incrementally funded contract and FAR 52.232-22 – "Limitation of Funds" applies.
