**RE: Change in Radiation Safety Officer – License No. 45-16452-01** / *03011069*

Dear Sir or Madame:

Advex Corp. would like to amend the above referenced license to designate a change in Radiation Safety Officer. Effective January 9, 2017 Mr. Lawrence R. Stippich will assume the duties and responsibilities of Radiation Safety Officer (RSO). Mr. Stippich was previously designated as the Advex Corporation Radiation Safety Officer from July 6, 2007 until August 12, 2009.

Lawrence Stippich has been involved in radiography since July 8, 1987, acting as Radiographer Assistant, Level II Radiographer, and ASNT NDT Level III Radiographer. Mr. Stippich successfully completed Radiation Safety Officer Training with the DOT option on June 22, 2007. Mr. Stippich far exceeds the required 2,000 hours as evident through his years of experience and prior position at Advex Corporation as Radiation Safety Officer from July 6, 2007 until August 12, 2009. Although Mr. Stippich doesn't currently completely meet the requirement of 10 CFR 34.42, his prior experience both as a radiographer and as the Advex Radiation Safety Officer for several years makes him qualified for this position.

Mr. Stippich will be provided refresher training and testing to obtain his IRRSP recertification and training/recertification for DOT HAZMAT for shipping of radiographic materials. We anticipate this will be completed prior to March 17, 2017. As of January 3, 2017 Mr. Michael E. Slep will provide assistance to Mr. Stippich and security oversight until Mr. Stippich has completed his refresher training. Mr. Slep was the Advex Radiation Safety Officer from May 1, 2012 until September 11, 2015 and has current IRRSP and DOT certifications and is in complete compliance with 10 CFR 34.42.
