Re: Trust Agreement dated July 31, 2013, by and between Bristol-Myers Squibb Company (“Grantor”) and JPMorgan Chase Bank, NA as Trustee (the “Trust Agreement”) related to the following: NJDEP License Number 425341, NJDEP License Number 507395, NYS DOH License Number 0931-0311 and NRC License Number 06-27843-02. The United State Nuclear Regulatory Commission, the New York State Department of Health and the New Jersey Department of Environmental Protection are the “Beneficiaries” of the Trust Agreement.

Dear Ladies and Gentlemen:

Pursuant to Section 13 of the Trust Agreement [as supplemented by a Side Letter dated July 31, 2013], the Trustee hereby notifies you of its intent to resign as Trustee under the Trust Agreement and that such resignation shall be effective one hundred twenty (120) days after the date of this letter, on May 10, 2017.

Grantor has the right to appoint a successor trustee, and such successor trustee shall specify the date on which it assumes administration of the trust in a writing sent to the Grantor, the Beneficiaries and the Trustee. The appointment of the successor trustee must be agreed to in writing by the Beneficiaries, stating that the successor trustee is an appropriate Federal or State government agency or an entity that has the authority to act as a trustee and whose trust operations are regulated and examined by a Federal or State agency. If Grantor fails to provide the Trustee with a written notice instructing the Trustee to pay over all funds held in the trust fund to the successor Trustee prior to the close of business on May 10, 2017, then, as provided for in Section 13 of the Trust Agreement, the Trustee may apply to a court of competent jurisdiction for the appointment of a successor trustee or for instructions.
