4 The topic of today's meeting is an affirmation and
5 possible discussion session on several items listed in the agenda,
6 and I will ask the Secretary to walk us through them.

7 MR. HOYLE: Mr. Chairman, two items on the agenda
8 have been scratched and will be on at a later time. It's
9 SECY 81-245A, the interim rule on hydrogen control; and 81-486,
10 petition for extension of deadline for environmental qualifications
11 of Class 1E electrical equipment.

12 The paper that is ready is SECY 81-529. This paper
13 has in it an order responding to a petition requesting a hearing
14 on the renewal of a byproduct materials license for the AFRRI.

15 Mr. Chairman, the votes that have come in are that
16 you and Commissioner Bradford and Commissioner Gilinsky have
17 approved the order with a modification.

18 Commissioners Ahearne and Roberts have not approved
19 that order, and would prefer to await an OGC paper.

20 Since Commissioner Roberts and Commissioner Gilinsky
21 are not in the room, those of you present would represent a quorum,
22 with the majority of the Chairman and Commissioner Bradford.

23 May I ask you to affirm your votes?

24 (A chorus of ayes.)

25 MR. HOYLE: Mr. Chairman, that's all I have.

1 COMMISSIONER AHEARNE: May I ask OGC a question?
2 Len, is it correct that the Board will have to
3 address the question of standing?

4 MR. BICKWIT: That is correct.

5 CHAIRMAN PALLADINO: Any other questions? Any other
6 items?

7 MR. HOYLE: Not from this end of the table, Mr.
8 Chairman.

9 CHAIRMAN PALLADINO: Well, thank you, and we will
10 stand adjourned.
