AMENDMENT REGARDING NAME CHANGE TO LIGHTING TECHNOLOGIES
INTERNATIONAL

Dear Mr. Buckhanon:

This letter refers to your letter dated January 20, 2017 (Agencywide Documents Access and Management System [ADAMS] Accession No. ML17030A260), which responded to our request for additional information concerning Exempt Distribution License 04-35176-01E. In reviewing your response, we have determined additional information is required to complete our review. In order to continue our review, please address the issues listed below. This information is required by Title 10 of the *Code of Federal Regulations* (10 CFR) 40.52, "Certain items containing source material; requirements for license to apply or initially transfer."

1. In accordance with 10 CFR 40.13, provide a copy of your radioactive material possession and use license issued by the State of California reflecting the name change of your company.
2. In your response letter, you provided a sample of the label for "inner lamp box" that shows the trademarks "Philips" without the identification of the manufacturer or initial transferor of the product as required. Provide a new label for the device indicating the new company name and the effective date of the label change.

We will continue our review upon receipt of this information. If we do not receive a reply from you within 30 calendar days from the date of this letter, we will assume that you do not wish to pursue your application.

Please be aware that upon your request, proprietary information submitted to the NRC may be withheld from public disclosure. To do this, you must follow the procedures in 10 CFR 2.390(b) including requesting withholding at the time the information is submitted and complying with the document marking and affidavit requirements set forth in 10 CFR 2.390 (b)(1).

In accordance with 10 CFR 2.390 of the NRC's "Agency Rules of Practice and Procedure," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records component of NRC's ADAMS. ADAMS is accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>.
