## **SUMMARY**

By letter dated November 18, 2016, TN Americas LLC requested an amendment to Certificate of Compliance No. 9233, for the Model No. TN-RAM transportation package. The letter requested name changes on certain certificates of compliance due to corporate reorganization. The certificate has been updated to Revision No. 14 to reflect the changes.

## **EVALUATION**

The purpose of the amendment was to change the name of the entity the certificate of compliance is issued to from "AREVA Inc." to the new name "TN Americas LLC." TN Americas LLC also submitted a description of its Quality Assurance Program Description Manual, Revision No. 15, for which Quality Assurance Program Approval for Radioactive Material Packages No. 0250, Revision No. 22, was issued by NRC on December 13, 2016. Certificate of Compliance No. 9233, Revision No. 14, is being issued under this Quality Assurance Program Approval.

These changes do not affect the ability of the package to meet the requirements of 10 CFR Part 71.

## **CONDITIONS**

The following changes have been made to the certificate of compliance:

Section 3.a. of the certificate of compliance has been revised to reflect the new name of the certificate holder, as requested.

Condition No. 10 now allows use of Revision 13 of the certificate until January 31, 2018.

The new Condition No. 11 reflects the previous Condition No. 10, the certificate expiration date of January 31, 2021.

The References section has been updated to include the name change request.

## **CONCLUSION**

Based on the statements and representations in the amendment request, the staff finds that these changes do not affect the ability of the package to meet the requirements of 10 CFR Part 71.
