Dear Mr. Feliciano:

This refers to your license amendment request dated December 12, 2016. Please find enclosed Amendment No. 16 authorizing the use and storage of the Theragenics I-Seed Model AgX100 therapeutic brachytherapy seed. In addition, based on the conversation I had with Miguel Rios on January 26, 2017, your previously authorized seed, Medi-Physics, Inc. Model 6711 OncoSeed™ was removed from your license as he indicated you no longer possess these seeds and they are no longer available.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC.
