Dear Ms. Kolkman:

The Land Quality Division (LQD) staff has completed technical review of the Jane Dough Amendment to revise the Nichols Ranch Permit. All outstanding comments have been addressed. This letter declares this Amendment application *technically adequate* and suitable for Public Notice and filing with the County Clerk per W.S. § 35-11-406(j).

Uranerz Energy Corporation shall publish one (1) notice of the pending Amendment application, commonly known as the Jane Dough Amendment, in a newspaper of general circulation in Johnson County and Campbell County, WY commencing within fifteen (15) days of receipt of this letter. The public notice for the pending mining operation shall run once a week over four (4) consecutive weeks with a 30 day comment period after the last publication. The public notice for the proposed groundwater classification and aquifer exemption will be published by Wyoming Department of Environmental Quality, Water Quality Division, Ground Water Section. Publication and comment period for this notice is governed by Water Quality Rules and Regulations.

Per Noncoal SOP No. 1.4, the notices must be mailed to all surface owners of record of the land within the proposed permit area, to surface owners of record of immediately adjacent lands, and to any surface owners within one-half (½) mile of the proposed permit area. Proof of notice and sworn statement of mailing shall be submitted to the DEQ LQD District III office to become part of the application. It should be understood that neither the Clerk filing nor the public notice in any way constitute tentative or preliminary approval of this Amendment application.
