

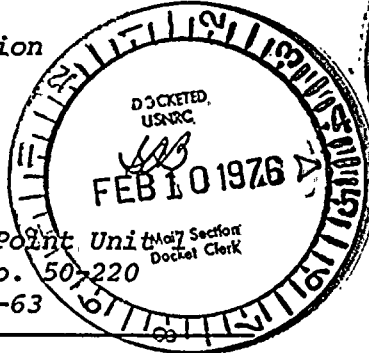

Dear Mr. Lear:


Our December 12, 1975 letter reported that General Electric was in the process of performing additional tests on a 1/12th scale model segment of the torus to obtain data for identifying net downward and upward support column loads. In addition, a structural analysis would be performed to determine the adequacy of the columns using those loads.

The results of this testing and analysis were presented to the Nuclear Regulatory Commission at a January 28, 1976 meeting. Based on that information, it is concluded that continued operation of Nine Mile Point Unit 1 does not present an undue safety hazard to the public.

An independent review of the information presented to the Commission is currently underway. Niagara Mohawk will inform the Commission of these findings upon completion of that review, expected during the week of February 15, 1976.


