

Your letter of March 20, 1978 requested an evaluation of the effect on the Nine Mile Point Unit 1 containment of multiple subsequent actuations of safety/relief valves following a postulated isolation event. Your letter also transmitted criteria for this evaluation. This evaluation is part of the Mark I Containment Long Term Program; therefore a common approach will be taken.

Due to the generic issues involved, we are unable to submit a response in the time frame requested. However, an evaluation for Nine Mile Point Unit 1 will be submitted on or before July 31, 1978.
