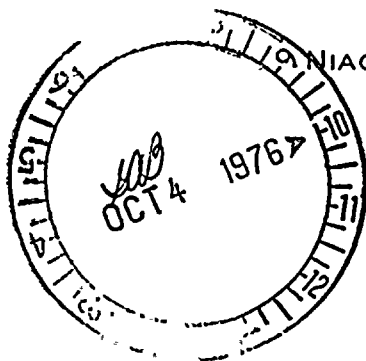

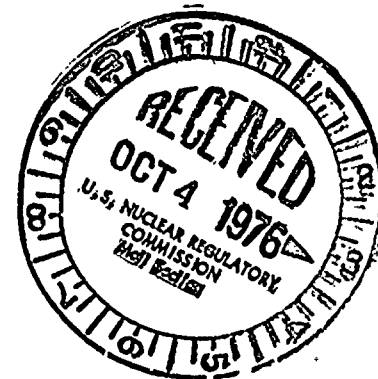

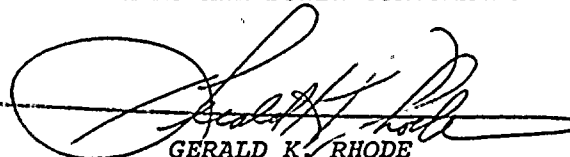
Dear Mr. Lear:
