This will acknowledge receipt of your letter of July 19, 1973, concerning fuel densification effects in the Nine Mile Point Nuclear Station Unit 2 core.

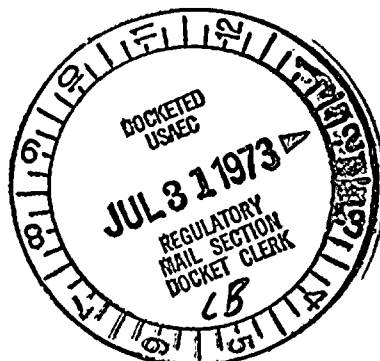
