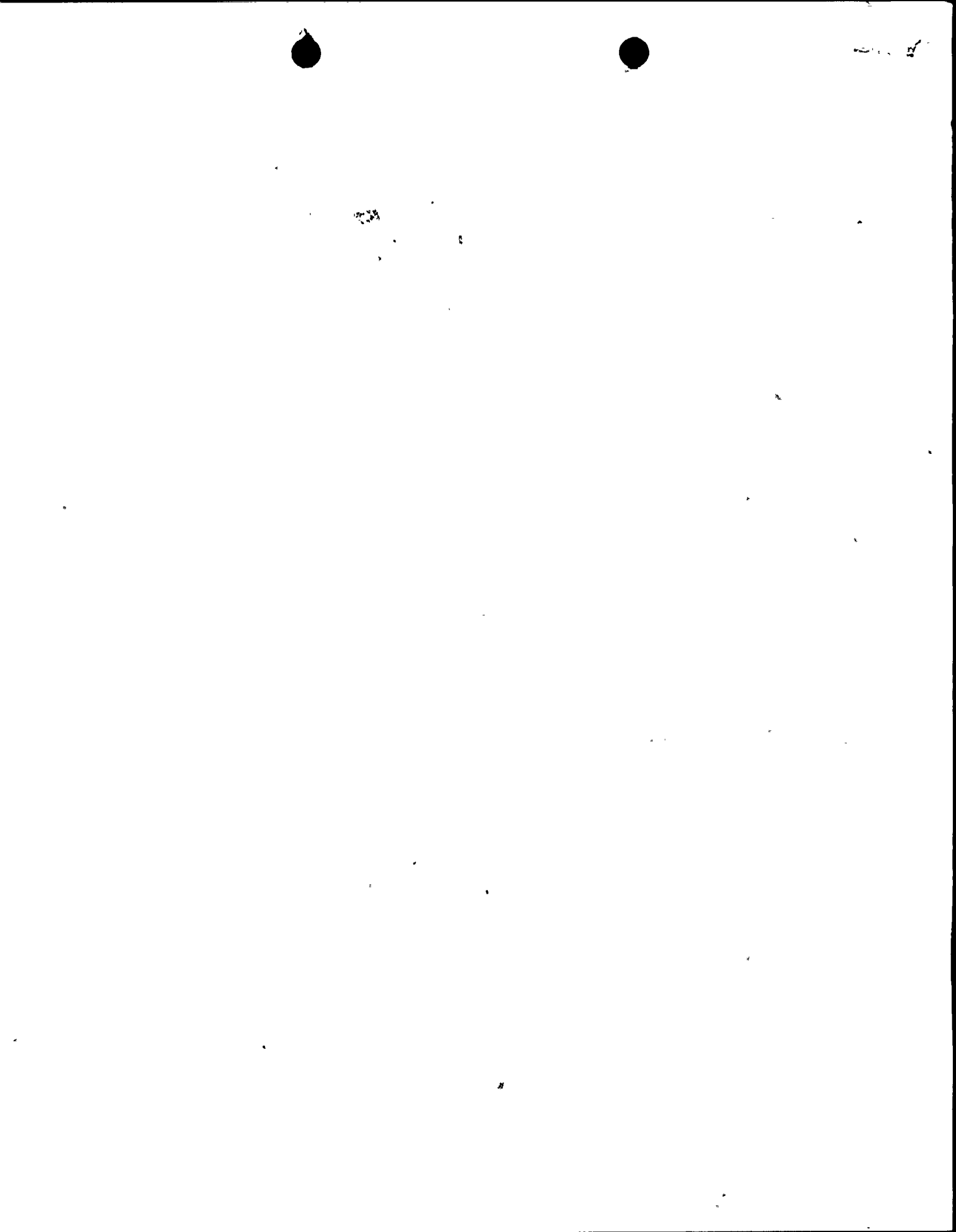

Dear Dr. Seymour:

This is to inform you that in an attempt to be more responsive to the needs of the public, the Commission has established locations where members of the public can inspect documents relating to applications for nuclear power plants that are currently under review or licensed for operation by the Commission. These locations are in close proximity to the nuclear facilities and, in most instances, are in public libraries to provide easy access to the public.

In this connection, the Commission has established a document room at the Oswego City Library, 120 East Second Street, Oswego, New York 13126, which contains information relating to Units 1 and 2 of the Nine Mile Point Nuclear Station located in the Town of Scriba, Oswego County, New York, and owned by the Niagara Mohawk Power Corporation (NMP). Unit No. 1 has been operating since August 1969 under Provisional Operating License No. DPR-17 issued by the Commission on August 22, 1969. The Commission currently has under review an application by NMP dated June 7, 1972, for construction of Unit 2.

We will provide the above document room the following non-proprietary types of documents relating to these facilities: NMP's applications and amendments and changes thereto; Commission actions thereon; requests for additional information; NMP's environmental reports and supplements thereto; AEC Draft and Final Environmental Statements and comments thereon; AEC Safety Evaluations; Reports of the Advisory Committee on Reactor Safeguards; operating, special and incident reports filed by NMP; and all related Federal Register notices. It also will receive copies of any advice rendered by the Attorney General and items relating to any public hearing that might be held in the future in connection with these facilities.

The records for Nine Mile Unit No. 1 at the above document room will not be complete in that we only have provided copies of Construction Permit No. CPPR-16 and Provisional Operating License No. DPR-17, and all amendments, changes and orders related thereto. We have not provided copies of NMP's initial applications and amendments thereto for Unit 1 that were filed prior to January 1972. Beginning January 1972, and henceforth, it has been and will continue to be provided with all of the types of items described in paragraph 3 above.

A copy of the above-referenced application by NMP dated June 7, 1972, for Unit No. 2 will be forwarded to you in the near future by a separate letter. All future amendments related to Unit 2 and requests filed in connection with Unit 1, and significant Commission actions thereon will be forwarded to you for your information.

By a copy of this letter, the following local officials also are being informed of the establishment of this document room. They too will receive copies of Commission actions taken relating to these facilities.
