We have completed a review of the General Electric Company proprietary topical report NEDE-10958, "General Electric BWR Thermal Analysis Basis (GETAB): Date, Correlation and Design Application" (NEDO-10958, is the non-proprietary version). Enclosed is our evaluation of this report.

As a result of our review, we have concluded that the above report provides an acceptable boiling transition correlation and an acceptable method of thermal analysis of the GE BWR 8x8 and 7x7 fuel assemblies.

In this regard, the revised GETAB-based Technical Specifications and supporting analyses for the Nine Mile Point Nuclear Station Unit 1 should be submitted no later than the submittal date of your ECCS re-evaluation required by the Order transmitted to you on December 27, 1974.
