If I can be of further assistance in this matter, please let me know.

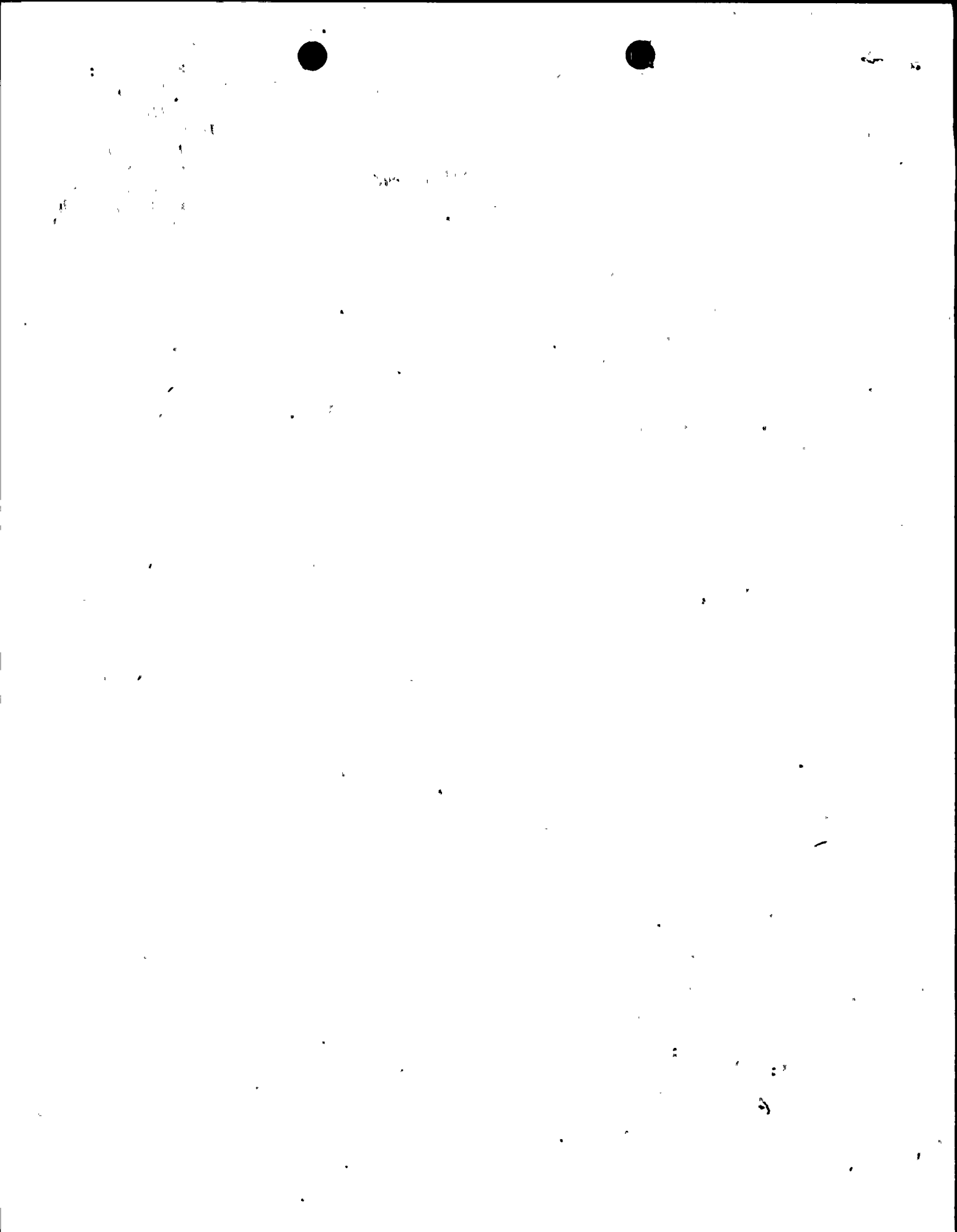
