This is in reply to Mr. Roger Boyd's letter of February 29, inviting our comments on Niagara Mohawk Power Corporation's letter regarding its proposed environmental monitoring program for the Nine Mile Point Nuclear Station, New York, Docket No. 50-220.

We are pleased to note that the applicant plans to conduct periodic environmental studies in the vicinity of the plant, both before the start of plant operation and for at least two years after initial plant operation, regardless of the radioactivity discharge level from the plant. We are also pleased to note that the applicant would make any appropriate revisions in the surveillance program or plant operations as found necessary on the basis of the data obtained from these surveys. We request that copies of the results of these surveys be provided to the Secretary of the Interior as soon as the data are compiled.
