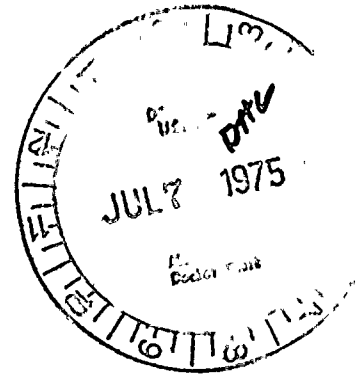


Dear Mr. Goller:
