Subject: Clarification of Application for License Renewal

Discussion: I discussed with Roger Askew 3 items on their application for license renewal:

1. On page B-1 of the application it states activity of the Cs-137 source is 8 mCi and on the SSD for the Troxler gauges it states 9 mCi. The RSO agreed with the SSD and it will be changed to 9 mCi.
2. On page B-1 of the application it states activity of the Am-241 source is 40 mCi and on the SSD for the Troxler gauges it states 44 mCi. The RSO agreed with the SSD and it will be changed to 44 mCi.
3. On page B-7 of the application, section 10.8 the "Non-routine Maintenance" box was not checked off and the RSO replied he misunderstood the wording and the licensee will send gauges back to the manufacturer or an entity licensed to perform non-routine maintenance.
