
Memo To: Radiation Safety Officer

From: President and Chief Executive Officer

Subject: Delegation of Authority


You, Darrell Williams, are formally appointed to the role of Radiation Safety Officer at the NSF Ann Arbor facility and are responsible for ensuring the safe use of radiation. You are responsible for managing the Radiation Protection Program; identifying radiation protection problems; initiating, recommending, or providing corrective actions; verifying implementation of corrective action; stopping unsafe activities; and ensuring compliance with regulations. You are hereby delegated the authority necessary to meet those responsibilities, including prohibiting the use of byproduct material by employees who do not meet the necessary requirements and shutting down operations where justified to maintain radiation safety. You are required to notify management if staff does not cooperate and does not address radiation safety issues. In addition, you are free to raise issues with the Nuclear Regulatory Commission at any time. You will be responsible to ensure that NSF International requirements are effectively sustained in accordance with NRC Regulations and other appropriate or referenced regulations.

You shall continue to maintain your current responsibilities for NSF International.
