#### Status of Recommendations

Recommendation 1: Develop and implement controls to ensure mandatory and discretionary language used in inspection procedures is clear and consistent.

#### Agency Response

Dated January 17, 2017: Action Complete. Controls have been developed and implemented via revision and issuance of Inspection Manual Chapter (IMC) 0040, "Preparing, Revising and Issuing Documents for the NRC Inspection Manual." IMC 0040 has been revised and issued, effective January 01, 2017, providing strengthened provisions and controls associated with establishing mandatory and discretionary inspection language in inspection documents. IMC-0040 now contains clear governance, regarding the use of mandatory and discretionary language, which shall be followed by inspection program document leads when revising, updating, or creating new inspection manual chapters and inspection procedures. The Division of Inspection and Regional Support, in the Office of Nuclear Reactor Regulation, considers the actions described above are fully responsive to Recommendation 1, with this manual chapter change and associated controls in place, procedure revisions are underway to ensure that discretionary and mandatory language used in existing inspection procedures is in alignment with the strengthened provisions in IMC-0040. These procedure revisions are expected to be completed by December 31, 2017. Finally, as part of the ROP's continuing periodic assessment process, outlined in Appendix B to Inspection Manual Chapter (IMC) 0307, "Reactor Oversight Process Baseline Inspection Procedure Reviews," the staff has undertaken actions to ensure that baseline inspection procedures continue to be reviewed, and if necessary, revised to ensure mandatory and discretionary language remains clear and consistent.
