

PROGRAM SCOPE

This was an unannounced routine inspection of a waste management company. The licensee had previously possessed six fixed gauges as described on the license, each with a 100 mCi cesium-137 source, but had disposed of the devices in August 2016 through a licensed waste broker. The licensee had not yet received documentation of the final receipt of the devices at the disposal facility in Texas, but intended to request termination of the license once that documentation was received. The radiation safety officer remained employed at the facility, but the environmental manager was leading the effort to dispose of the gauges and terminate the license. The inspector briefed the environmental manager on the requirements in 10 CFR 30.36 concerning termination of licensed activities.

Performance Observations: The inspector reviewed documentation concerning the disposal of licensed materials, and noted no concerns with the documentation.

No violations were identified during this inspection.
