
Dear Ms. Frazier,

It has come to our attention that Condition 10A (**Licensed material listed in Sub-item Nos. 6.A. through 6.F. and 6.I. may be used at the licensee's facilities located at 1000 Harrington Boulevard, Mount Clemens, Michigan.**) is omitted in the Amendment 64 of our NRC License # 21-04080-01. We didn't ask to remove it in our last application dated October 19, 2016. This omission affects our clinical operation as we unable to receive by product materials under CFR 35.300.

I'll appreciate it very much if the above mentioned condition could be restored as soon as possible.
