This refers to your license amendment request dated November 30, 2016. Please find enclosed Amendment No. 47 authorizing the removal of manual and high dose-rate remote afterloading (HDR) brachytherapy and the removal of Drs. Reddy and Nguyen. The facility previously used for HDR may be released for unrestricted use. In addition, please note that the authorized medical physicists have been removed from your license since their authorized use was removed.

An environmental assessment for this action was not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. You will be periodically inspected by the NRC.
